For Custom-built Participation Exhibitors, Form 1 (Custom-built Participation Contractors' Information), construction drawings, site work deposit and a copy of valid public liability insurance should be provided to Mr Aston Fong (aston.wh.fong@hktdc.org)/ Ms. Kristy Lee (kristy.wm.lee@hktdc.org), Exhibition Services Department, Hong Kong Trade Development Council no later than **09 March 2026**. Otherwise, a late submission fee of **HK\$3,000 (US\$400)** will be applied to the Exhibitor or its appointed contractor.

Drawings submitted must be in a reasonable scale of at least 1:100, fully dimensioned and must contain information such as floor plan, stand elevation, electrical fittings, carpeting, colours and materials to be used, moving exhibits, audio-visual equipment, weights and point loading of exhibits etc. Any alterations after drawing submission should be addressed to the Organiser for review.

### Site Work Deposit

Exhibitors/Contractors of custom-built participation are required to lodge a site work deposit which will be collected based on **HK\$300 / US\$40 per sqm**. For two-storey construction stands, site work deposit is doubled. However, the **minimum and maximum deposit amounts are HK\$5,000 (US\$667) and HK\$75,000 (US\$10,000)** respectively.

Deposits paid will be refunded within **THREE months** after conclusion of the Fair if the exhibition sites are, in the Organiser's view, clear of damage to the exhibition hall and all rubbish is cleared according to the time schedule of the Organiser and without violating the conditions as stipulated under section 4.2.15 of Exhibitors' Manual. Otherwise, costs incurred by the Organiser will be deducted from the deposit.
